

STUD SERVICE AGREEMENT

This agreement is made and entered between Janet Rufo of Straight Shooters Stud Services (hereinafter "Owner") and ______, (hereinafter "Breeder"). These terms and conditions are entered into and agreed upon by both Owner and Breeder.

Owner agrees to breed the named Stud Dog, _______ to the named Bitch: ______ with the following conditions:

Stud Fee:

Breeder agrees to pay \$ 3,000.00 (Three Thousand Dollars) in cash in advance of the first breeding. For breedings at our site, this includes one or two (breeder's choice) breeding sessions with the same participants. For AI and TCI- based breedings, collection and shipping costs are included. In both cases, we will provide a complimentary repeat breeding with the same female at the next heat cycle if no pregnancy takes place. AI and TCI customers will be charged for collection and shipping in this case.

Extra Costs:

If you are bringing your female to our location for breeding, we will require proof of a negative Brucellosis test within the last 30 days. If you do not have this, we will conduct a Brucellosis test upon arrival for \$50.00. The Brucellosis test is NOT "optional." (A positive test will result in cancelation of the breeding.) A Progesterone test is also highly recommended in advance to pinpoint the optimal day for breeding. If the Breeder does not provide test results to us before the breeding, we can do a Progesterone test for \$50.00. If the Breeder elects not to do Progesterone testing, and the female does not get pregnant, no complimentary repeat breeding will be offered.

Guarantees by Owner:

The stud is a good representation of his breed and has a sound, stable temperament. He is current on vaccinations and free of internal and external parasites. If the Breeder performs progesterone testing and the bitch fails to conceive and does not deliver a "live litter" (defined as a litter of two (2) or more living puppies), Breeder has the option of a free repeat stud servicing on the bitch's next season. This repeat service ONLY applies to the stud dog and bitch named above in this contract. If a repeat breeding is selected and artificial insemination is the method used, Breeder will be responsible for the costs associated with additional semen collection and shipments, and all costs incurred during or as the result of an AI breeding as listed above. If Breeder elects NOT to perform progesterone testing, Owner makes no guarantees, no portion of the stud fee will be returned and no free repeat breeding will be offered. Owner can provide Breeder with both Brucellosis and Progesterone testing at \$50 per test.

Guarantees by Breeder:

The bitch is a good representation of her breed and has a sound, stable temperament. She is in good health and current on vaccinations and free of internal and external parasites. Breeder must provide proof of brucellosis testing of her bitch which has been completed within the past ninety (90) days. The Breeder guarantees that the stud fee will be paid BEFORE the time of breeding, in cash, and accompanied by a signed copy of this contract. The breeder agrees that no puppy resulting from this breeding will be disposed of through pet stores, puppy mills, commercial breeders or brokers, or "resale" operations.
